Attached is the February 2021 edition of our iFlow Monthly, including iFlow Cloud and iFlow Hedge.

Among the insights in this month's edition:

- G10: Profitable overweights in GBP, DKK and CAD, while the EUR's unprofitable overweight persists from last month.
- APac: Overweights abound and, as in G10, are generally profitable: SGD, TWD, MYR, PHP, and INR (although the last is seeing negative flows).
- EMEA: Mostly profitable overweights in the region: HUF, CZK, ZAR, PLN. RUB overweight but losing money.
